### Why is compliance important in higher education

Compliance in higher education refers to the adherence of tertiary institutions to laws, regulations, standards, and ethical practices set by government bodies and regulatory authorities. In Australia, compliance is a fundamental aspect of the higher education sector, ensuring not only the quality of education but also the protection of students, staff, and the reputation of the institutions themselves.

#### **Maintaining Standards**

Australian higher education institutions are required to meet rigorous standards set by regulatory bodies such as the Tertiary Education Quality and Standards Agency (TEQSA). Compliance ensures that these 'threshold standards' are consistently met, maintaining the quality and integrity of degrees and qualifications offered. This, in turn, fosters trust among students, employers, and the broader community regarding the value of Australian education.

# **Protecting Students and Staff**

Compliance frameworks encompass policies on student safety, privacy, equal opportunity, and workplace health and safety. Adhering to these regulations helps create a safe, inclusive, and fair environment for all members of the academic community. This is particularly important for international students, who may be unfamiliar with local laws and expectations.

### **Safeguarding Reputation**

Non-compliance can lead to significant reputational damage, legal consequences, and financial penalties for institutions. Maintaining compliance demonstrates a commitment to ethical conduct and responsible governance, which is essential for attracting students, staff, and funding from both domestic and international sources.

## **Supporting Continuous Improvement**

Compliance is not merely about meeting minimum standards (in the higher education context referred to as 'threshold standards') - it also drives *ongoing improvement*. Regular audits, reviews, and self-assessments – often referred to a 'rolling audits' - encourage institutions to evaluate their practices, identify areas for enhancement, and implement best practices in teaching, scholarship and administration.
